

2020 Voter Information

You have 3 voting options for the 2020 Election:

IN-PERSON VOTING - 1ST CHOICE. Early Vote - Oct. 17-30, or on Election - Day Nov. 3.

ABSENTEE BALLOT - 2ND CHOICE. Must be requested by Voter.

MAIL-IN BALLOTS - 3RD CHOICE. For 2020 all active voters will receive a Mail-In ballot.

Do Not Surrender your Mail-In ballot to anyone. Follow instructions on filling it out and make sure you sign it. Then drop it off at a polling place. Do not MAIL it in.
